MINUTES OF THE CUSTER CO. BOARD OF SUPERVISOR

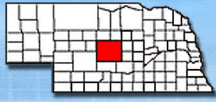
June 13th, 2017

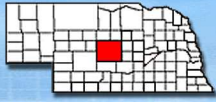

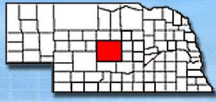
