MINUTES OF THE CUSTER CO. BOARD OF SUPERVISOR

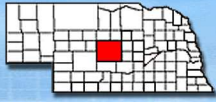
July 10th, 2018

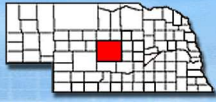

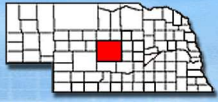
Motion by Olson, 2nd Eggleston, to approve an application for Consolidated Companies, to go under road with fiber optic cable. Roll call vote. Ayes-all
