MINUTES OF THE CUSTER CO. BOARD OF SUPERVISOR

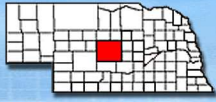
November 27, 2018

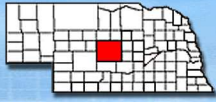

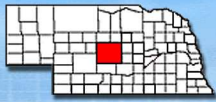

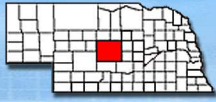
