MINUTES OF THE CUSTER CO. BOARD OF SUPERVISOR

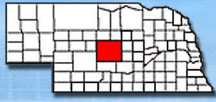
March 12, 2019

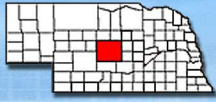

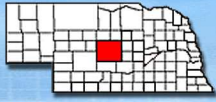

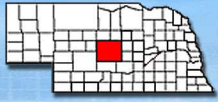
Motion by Eggleston, 2nd Bryner, to open a Public Hearing @10:45 a.m. on Recycling Center. Roll call vote. Ayes-all
