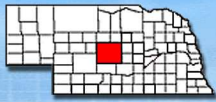

Motion by Eggleston, 2<sup>nd</sup> Olson, to open a Public Hearing on Rd. #325 1/2 and Mason City railroad crossing. Roll call vote. Ayes-all
