MINUTES OF THE CUSTER CO. BOARD OF SUPERVISOR

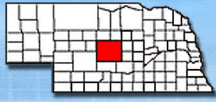
March 9, 2021

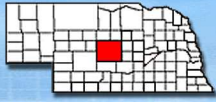

L. Lymber, Co Assessor, presented Permissive Exemption application for Sandhills Bible Ministries, on a storage building.

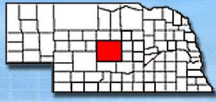
