MINUTES OF THE CUSTER CO. BOARD OF SUPERVISOR

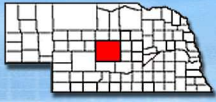
June 29, 2021

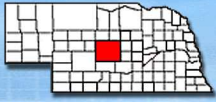

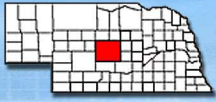
