## MINUTES OF THE CUSTER CO. BOARD OF SUPERVISOR

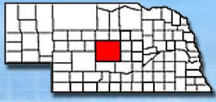
July 13, 2021

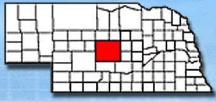

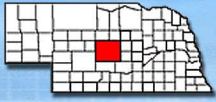

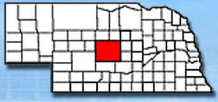
